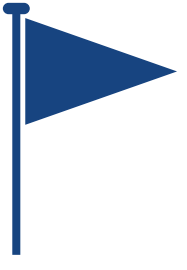


# COVID-19 EXECUTIVE ORDERS CHEAT SHEET

## STATEWIDE



### ARENAS

- INDOOR AND OUTDOOR ARENAS ARE LIMITED TO NO MORE THAN 25% CAPACITY.
- CONCESSION STANDS MUST REMAIN CLOSED.

- [EXPIRATION: AUGUST 17](#)



### BARS

- BARS CAN ONLY SELL ALCOHOL TO SEATED CUSTOMERS, AND NO ALCOHOL CAN BE SOLD AT RESTAURANTS OR BARS AFTER 11:00 PM UNTIL 7:00 AM.
- NO MORE THAN 50% OF MAXIMUM CAPACITY. TABLES MUST BE 6 FEET APART WITH NO MORE THAN 6 CUSTOMERS PER TABLE.

### EMPLOYMENT/WORKPLACE

- EMPLOYEES ARE REQUIRED TO REPORT ANY SYMPTOMS OF COVID-19 TO THEIR EMPLOYERS AND MUST BE SENT HOME IMMEDIATELY.
- TELEWORK IS ENCOURAGED.

### GYMS

- NO MORE THAN 50% OF MAXIMUM CAPACITY.

### CONFERENCE CENTERS AND RECEPTION HALLS

- NO MORE THAN 25% OF MAXIMUM SEATED CAPACITY.
- IF A SEATED DINNER, NO MORE THAN 50% CAPACITY OF MAXIMUM CAPACITY WITH 6 FEET BETWEEN EACH TABLE AND A MAX OF 6 PEOPLE PER TABLE.

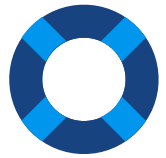

### HEALTHCARE

- ELECTIVE, NON-EMERGENT SURGERIES MAY BE PERFORMED AT HOSPITALS IF THE HOSPITAL RESERVES 10% OF ITS CAPACITY FOR TREATMENT OF COVID-19 PATIENTS, ACCOUNTING FOR A RANGE OF CLINICAL SEVERITY.

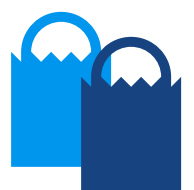
### POOLS

- POOLS MAY REMAIN OPEN 24 HOURS A DAY, MAINTAINING 6 FEET SEPARATION BETWEEN PEOPLE FROM DIFFERENT HOUSEHOLDS.
- MORE THAN 50% OF POOL CAPACITY.

### QUARANTINE

- VULNERABLE INDIVIDUALS, WHICH INCLUDE PEOPLE 65 AND OLDER AND THOSE WITH SERIOUS UNDERLYING HEALTH CONDITIONS, SHOULD REMAIN AT HOME AS MUCH AS POSSIBLE.

### RETAIL BUSINESSES

- GOOD FAITH EFFORTS TO COMPLY WITH CDC AND MSDH GUIDELINES TO PREVENT SPREAD OF COVID-19.
- CUSTOMER LIMIT OF 50% OF MAXIMUM CAPACITY.
- RETAIL BUSINESSES MUST FREQUENTLY CLEAN HIGH CONTACT SURFACES.
- RETAIL BUSINESSES ARE ENCOURAGED TO MAKE HAND SANITIZER AVAILABLE.

### RESTAURANTS & BARS

- DAILY SCREENING OF EMPLOYEES IS REQUIRED.
- RESTAURANTS MUST COMPLY WITH MSDH REGULATIONS, ORDERS, AND GUIDANCE.
- EMPLOYEES MUST BE TRAINED IN MINIMIZATION OF THE SPREAD OF COVID-19.
- NO MORE THAN 50% OF SEATING CAPACITY.
- 6 FEET OF SEPARATION BETWEEN PARTIES, AND NO MORE THAN 6 CUSTOMERS PER TABLE.
- CUSTOMERS WILL BE SCREENED FOR POTENTIAL COVID-19 SYMPTOMS UPON ENTRY.
- 6 FEET OF SEPARATION MUST BE MAINTAINED IN WAITING AREAS.
- HIGH CONTACT SURFACES MUST BE SANITIZED EVERY 2 HOURS.
- DISPOSABLE MENUS ARE ENCOURAGED, AND NON-DISPOSABLE MENUS MUST BE SANITIZED AFTER EACH USE.
- HAND SANITIZER MUST BE PLACE AT ALL POINTS OF ENTRY AND EXIT, NEAR THE HOSTESS STATION NEAR THE BATHROOMS AND NEAR THE CASHIER STATION.
- ALL FOOD SERVICE AREAS MUST BE DEEP-CLEANED.
- BARS CAN ONLY SELL ALCOHOL TO SEATED CUSTOMERS, AND NO ALCOHOL CAN BE SOLD AT RESTAURANTS OR BARS AFTER 11:00 PM UNTIL 7:00 AM.

- **EXPIRATION: AUGUST 17**



### SOCIAL GATHERINGS

- LIMITED TO 10 OR LESS INDOORS AND 20 OR LESS OUTDOORS, WITH THE FOLLOWING EXCEPTIONS:
  - 1) RELIGIOUS ENTITIES AND SERVICES
  - 2) CLASSROOMS
  - 3) GATHERINGS IN FACILITIES GOVERNED BY OTHER CAPACITY LIMITS
- **EXECUTIVE ORDERS: 1511, 1514**
- **EXPIRATION: AUGUST 17**



# COVID-19 EXECUTIVE ORDERS CHEAT SHEET

## STATEWIDE



### SPORTS COMPLEXES

- ALL PLAYERS MUST BE PROVIDED A COPY OF EXECUTIVE ORDER 1491 PRIOR TO RESUMING ORGANIZED PRACTICES.
- DUGOUTS SHALL NOT BE USED DURING PRACTICES, BUT THEY MAY BE USED DURING GAMES.
- PERSONAL BAGS AND EQUIPMENT MUST BE PLACED 6 FEET APART.
- PARENTS MUST REMAIN IN CARS DURING PRACTICES.
- SHARED EQUIPMENT MUST BE SANITIZED AFTER PRACTICES AND GAMES.
- SHARED DRINKING FOUNTAINS, COOLERS, AND SNACKS ARE PROHIBITED. PLAYERS AND FANS SHALL BE ALLOWED TO BRING PERSONAL COOLERS AND SNACKS TO THE COMPLEX.
- THE COMBINED NUMBER OF PEOPLE WATCHING A GAME CANNOT EXCEED 100.
- POST-GAME HANDSHAKES, HIGH FIVES, ETC. ARE PROHIBITED.
- POST-GAME TALKS AT THE FIELD ARE PROHIBITED.
- ONLY TWO HOUSEHOLD MEMBERS PER PLAYER ARE PERMITTED AT THE FIELD. NO BLEACHER USE—FANS MUST BRING THEIR OWN CHAIRS OR STANDS, AND SOCIAL DISTANCING MUST BE OBSERVED.
- EVERY LEAGUE, TOURNAMENT, OR EVENT MUST HAVE A DEDICATED SAFETY OFFICER TO ENSURE SOCIAL DISTANCING.
- FANS MUST REMAIN IN THEIR CARS UNTIL TEAMS AND FANS FROM THE PREVIOUS GAME HAVE EXITED THE AREA.
- CONCESSION STANDS AT SPORTS COMPLEXES MAY BE OPEN, BUT WORKERS MUST WEAR MASKS AND SOCIAL DISTANCING MUST BE OBSERVED.
- WORKERS MUST BE SCREENED PRIOR TO WORKING.

### MASKS

- EVERYONE MUST WEAR A MASK WHEN IN PUBLIC, WITH EXCEPTIONS SUCH AS CHILDREN UNDER 6 YEARS OLD OR FOR MEDICAL OR BEHAVIORAL CONDITIONS

### **APPLIES TO THE FOLLOWING COUNTIES:**

BOLIVAR, CALHOUN, CARROLL, CLAIBORNE, COAHAMA, COVINGTON, DESOTO, FORREST, GRENADA, HARRISON, HINDS, HOLMES, HUMPHREYS, JACKSON, JEFFERSON, JONES, LAMAR, LEE, LEFLORE, LOWNDES, MADISON, MONTGOMERY, NOXUBEE, PANOLA, PONTOTOC, QUITMAN, RANKIN, SHARKEY, SIMPSON, SUNFLOWER, TALLAHATCHIE, TATE, WALTHALL, WASHINGTON, WAYNE, WINSTON, AND YALOBUSHA



### **ALL BUSINESSES**

- CUSTOMERS MUST WEAR FACE COVERINGS, WITH THE FOLLOWING EXCEPTIONS:
  - 1) PERSONS WITH MEDICAL CONDITIONS WHO HAVE TROUBLE BREATHING OR ARE INCAPACITATED
  - 2) FOR COMMUNICATING WITH HEARING IMPAIRED LIP READERS
  - 3) WHILE EATING, DRINKING
  - 4) WHEN REQUIRED FOR SECURITY REASONS (FOR EXAMPLE, IN BANKS AND FINANCIAL INSTITUTIONS)
  - 5) SWIMMING, EXERCISING IN GYMS, AND SPORTS
  - 6) SPEECHES, PRESENTATIONS, OR PERFORMANCES
  - 7) IN CHURCH OR WHILE ENGAGING IN RELIGIOUS WORSHIP
  - 8) CHILDREN UNDER THE AGE OF 6
- BUSINESSES MUST PLACE SIGNS AT ENTRANCE(S) INFORMING CUSTOMERS OF FACE COVERING REQUIREMENTS AND SOCIAL DISTANCING REQUIREMENTS (6 FEET SEPARATION FROM OTHER CUSTOMERS IN CASHIER LINES, WAITING ROOMS, ETC).
- CARTS AND BASKETS MUST BE SANITIZED AFTER EACH USE.
- ALL OTHER HIGH TOUCH SURFACES, SUCH AS DOOR HANDLES, MUST BE SANITIZED EVERY 2 HOURS.
- INDIVIDUALS MUST KEEP A MINIMUM OF 6 FEET BETWEEN THEMSELVES AND OTHERS NOT IN THE SAME HOUSEHOLD.

### **APPLIES TO THE FOLLOWING COUNTIES:**

BOLIVAR, CALHOUN, CARROLL, CLAIBORNE, COAHAMA, COVINGTON, DESOTO, FORREST, GRENADA, HARRISON, HINDS, HOLMES, HUMPHREYS, JACKSON, JEFFERSON, JONES, LAMAR, LEE, LEFLORE, LOWNDES, MADISON, MONTGOMERY, NOXUBEE, PANOLA, PONTOTOC, QUITMAN, RANKIN, SHARKEY, SIMPSON, SUNFLOWER, TALLAHATCHIE, TATE, WALTHALL, WASHINGTON, WAYNE, WINSTON, AND YALOBUSHA



### **MASKS**

- EVERYONE MUST WEAR FACE COVERINGS WHEN AT PUBLIC AND SOCIAL GATHERINGS WHERE SOCIAL DISTANCING IS NOT POSSIBLE OR WHILE INSIDE A BUSINESS, WITH THE FOLLOWING EXCEPTIONS:
  - 1) ORGANIZED SCHOOL ATHLETIC PRACTICES
  - 2) OUTDOOR EXERCISING
- **EXECUTIVE ORDERS: 1509, 1512, 1515**
- **EXPIRATION: AUGUST 17**



### **SOCIAL GATHERINGS**

- LIMITED TO 10 OR LESS INDOORS AND 20 OR LESS OUTDOORS, WITH THE FOLLOWING EXCEPTIONS:
  - 1) RELIGIOUS ENTITIES AND SERVICES
  - 2) CLASSROOMS
  - 3) GATHERINGS IN FACILITIES GOVERNED BY OTHER CAPACITY LIMITS
- PEOPLE MUST MAINTAIN A 6-FOOT DISTANCE BETWEEN THEMSELVES AND OTHERS.
- **EXECUTIVE ORDERS: 1509, 1512, 1515**
- **EXPIRATION: AUGUST 7**
